Tracking Down Bruno Ernst Weber

ust drove back from Ohio in time to finish the third and final installment about my escapades in the Buckeye State. As I'm sure you'll remember, installments one and two were in the March and April newsletters which recounted my visit to the Warther Museum in Dover, riding an old time carrousel in Mansfield, and learning how to carve a folk art bird under tutelage of Henry Wood, Master Carver of Put In Bay.

Henry also took me around to see some great wood carvings on South Bass Island in Lake Erie (that's where the city of Put In Bay, Ohio is located) by Bruno Ernst Weber. Bruno was of German descent, born in Silesia on January 19, 1883 and died on August 5, 1953. He is buried in the Maple Leaf Cemetery in Put In Bay. Silesia was part of the Kingdom of Prussia which is now split between Poland and Czechoslovakia.

Bruno started to learn woodcarving at the age of 14 when he worked in a furniture factory. His father was an expert cabinet maker. After a four year apprenticeship in woodcarving, he traveled extensively, worked in many carving shops and gained experience in architectural carving, especially in fine works for churches.

In 1906, Bruno immigrated to the United States where he spent four months in New York before settling in Columbus, Ohio. There he worked for the U.S. Carriage Company, makers of hearses, and carved much of the work that they delivered.

After that he did architectural carvings for churches and fine residences in Columbus and surrounding cities. In 1935, Bruno had an exhibit of his carvings at the Columbus Gallery of Fine Arts. In 1939, he moved to Put In Bay and established a home on Langram Road where he lived until he died.

The first Bruno carving that Henry showed me was a boat sign that was carved out of an old oak table leaf. It had hung on a post by a man who rented boats, and was then thrown away into the woods when his house was demolished.



Henry had always admired the sign and went looking for it, found it, and was told that he could have it for \$3. I forgot to mention that Henry is a "dyed in the wool" dumpster diver with many treasures to his credit. The boat sign now hangs in Henry and Caroline's home in Centennial.

Henry knew that Bruno had carved a fireplace mantel for his home on Langram Road and called the current owners to ask if we could come and see it. They were gracious enough to invite us into their home, let me take some photos of the mantel, and tell us a little history about it. They said originally there were some detailed scenes on either side of Washington and Lincoln, but that Bruno needed some money and had to sell them.

He then carved some linen fold panels to fill in the void. Bruno also carved two totem poles out of some old timbers that came from a local barn that was razed and placed them to flank his driveway. One has a frontiersman theme and the other a Native American; they've had to be repainted several times over the years.



As reflected in his fireplace mantel, Bruno was a big fan of George Washington, Abraham Lincoln, and Oliver Hazard Perry. Perry was in command of the American fleet that defeated the British fleet just Northwest of Put In Bay on September 10, 1813. This was during the War of 1812 and gave control of the Great Lakes to the Americans. After the victory, Perry sent a message to his commander, General Harrison, "We have met the enemy and they are ours: two ships, two brigs, one schooner, and one sloop."

You should remember the first part of that from high school history, if you were paying attention. But enough of a history lesson: go to Google to get the whole story. Don't forget to read about the country's third tallest monument (352 feet) that in 1912—15, was built in Put In Bay to commemorate Perry's victory (I was at the top last week).

Next we went to Heineman's Winery, which is conveniently located just around the corner from Henry and Caroline's cottage, to see some more of Bruno's work whilst drinking some of their fine wines. At one time, going back into the 1800's, most of the three Bass Islands (South, Middle and North) were covered with vineyards and orchards which have now mostly been replaced with houses, tourist establishments, and a small airport. There we saw four carved plaques hung in the bar area and listened to stories from the elder Louis Heineman about his remembrances of Bruno sitting in the bar, drinking wine, and working on the carvings. I especially liked the one of Bacchus.

They were going to start picking grapes on the following Monday and I was offered a pickers job if I could have stayed longer.

Our final stop was the Mother of Sorrows
Catholic Church which contained a number
of Bruno's carvings. The only carving I got a
photo of was the near life size one of Saint
Teresa. The other church on the island, Saint
Paul's Episcopal Church, is located directly
across the street and although I didn't get to go
inside, Henry took a photo of a Bruno carving
in it that lists the members who were serving
in World War II. The Catholic Church had a
similar one, but its whereabouts are unknown.



I always enjoy hearing stories and seeing the work of woodcarvers from bygone times that made their living by carving. If you know anything about Bruno Ernst Weber or any other old time carvers that should be remembered, please let me know. The photo of Bruno and some of his story came out of "The Columbus Dispatch," dated May 31, 1935.




They would be tickled pink to hear from you and would probably even treat you to some fancy dessert with coffee.
